## INTERNAL COMPLAINT COMMITTEE

### Complaint mechanism :-

A complaint of various grievance ,sexual harassment & Ragging can be filed by the aggrieved students at the institution. There is a linear complaint mechanism through which the complaints get filed and the ICC performs its functions, thereby required actions are taken.

1. The complainant is supposed to file the complaint in writing and submit the same before the ICC. The Chairperson is empowered to obtain the complaint in writing by providing all assistance to the complainant.
2. The complainant can also send the complaint to any committee member via email.
3. Filing of a written complaint is mandatory which should include full name with other necessary details of the incident(s) of various grievance, sexual harassment & Ragging.
4. In case the complainant is not able to file a complaint by herself/himself, her/his legal heirs, spouse, or parents can file the same.
5. A third person can also be the complainant provided that a written complaint must be filed by the one who has been subject to sexual harassment & Ragging.
